



As a valued stakeholder, you are invited to comment on the [Planning Proposal](#) to reclassify 340 West Dapto Road, Stream Hill (Lot 1 DP 657171) from Community Land to Operational Land. The Planning Proposal is on exhibition from Wednesday 15 November 2023 to Wednesday 13 December 2023.

The objective of the Planning Proposal is to reclassify the Council owned land from Community Land to Operational Land, reflecting the established strategic intent of the site and as originally intended when Council purchased the land in 1998. The Strategic intent of the land is outlined in the West Dapto Vision and Wollongong Development Control Plan 2009 Chapter D16 – West Dapto Urban Release Area.

After the exhibition period has ended a further period of at least 21 days is to be observed before a public hearing is then conducted. Public Hearings are a requirement for Planning Proposals seeking to reclassify public land from community to operational land. Following the public exhibition period and public hearing, the Planning Proposal will be assessed, taking into account all stakeholder submissions and the public hearing report, and a Post Exhibition Report will be prepared for consideration at a meeting of Council.
