ADDITIONAL INFORMATION

SECTION A - REAL PROPERTY

For the purposes of this section "interest" includes an option to purchase.

SECTION B - SOURCES OF INCOME

Only provide information where the amount of income from that source exceeds \$500. Fees paid to the Lord Mayor and Councillors under the *Local Government Act 1993* do not need to be disclosed.

Examples of **OCCUPATIONS** could include: an employee of Council, an employee of other organisations, self-employment, consultant, an office holder in a company.

The 'Settlor' is the name of a person who created the TRUST.

Examples of OTHER INCOME could include rental income from property.

SECTION C - GIFTS

You do not need to include every gift you receive in your duties. You only need to include a description of a single gift or multiple gifts from the same donor, the total value of which exceeded \$500 in the reporting period.

Gifts include any item, property or money you have been given without consideration or with inadequate consideration, unless it was received under a will.
