- 6 Responses **6.1 Offshore Windfarms:**

It was agreed that Alison Byrnes be thanked for her response and that we apologise if we have misunderstood the approval process. We had assumed that because under Section19 (1) of the Offshore Electricity Infrastructure Act 2021, the Minister, before deciding whether an area is suitable for offshore renewable energy infrastructure, was obliged to have regard to "the potential impacts of the construction, installation, commissioning, operation, maintenance or decommissioning of offshore renewable energy infrastructure in the area on other marine users and interests" the Minister would have to ensure these studies had been undertaken before making a decision.

 (wollongong@parliamenmt.nsw.gov.au) expressing alarm that, contrary to the situation in Sydney, neighbours to medium density housing proposals, which comply with State controls in ordinary residential streets, are not notified, and have no opportunity to comment nor see the plans;
- Council again be requested to reinstate the requirement for readily visible on-site notification when Das are submitted.

9.1 DA-2022/469 24 dwellings 14, Cosgrove Ave, Keiraville

DLM Tania Brown advised Agenda item 3 for Council meeting 8th April re large R2 zoned lots in the Illawarra Escarpment Foothills includes reference to this site.

It was agreed that a submission of strong objection be lodged to this further apparently ambit DA.

9.2 Economic Development

DLM Tania Brown expressed concerns about the termination of Business Illawarra Executive Director and potential centralisation by Business NSW.

It was agreed that Council be urged to:

- 1 review its current strategy and practice for attracting employment to the city;
- 2 review and follow through on the economic initiatives set out in the 2011 Neighbourhood Forum City Strategy Study;
- 3 specifically identify companies with the potential to set up in Wollongong and actively promote to them.

9.3 Mount Ousley Interchange

It was agreed that

- a small NF5 working party led by the acting Convenor be formed to liaise with TfNSW and contractor Fulton Hogan re the MOI, including about feedback from residents and suggested improvements to the project scope and design announced in project update 28 March 2024 and report on progress;
- The local Federal and State Members be kept informed of progress with TfNSW negotiations;
- Representations be made to MP Ryan Park to request TfNSW to retain the agreed pedestrian bridge access over Mount Ousley Road.

9.4 Affordable Housing

Despite widespread need, cost shifting burdens on Councils make it impossible for them to make much impact on the provision of affordable housing.

It was agreed that Council be urged to make representations through local MPs to relevant Ministers for the State and Federal governments to provide far more funding to ameliorate the continuing socially destructive under-provision of affordable housing.
