7/06/2012	1	Clearance of clippings, Cater Street, Coledale	Can council please confirm whether the clippings have been cleared?	City Works	The clippings have been cleared.
7/06/2012	2	Footpath between North Austinmer & Seacliff Bridge, LHD	Are there any plans for an upgraded main footpath to be included in the Grand Pacific Walkway plan? If so, is there a timeframe for an upgrade?	Infrastructure	The Delivery Program 2012-17 available on the W.C.C. website contains a summary of Major capital projects on page 31 of Attachment 3. One of the projects listed is Grand Pacific Walk - North Wollongong to Otford - concept design, staging and alignment for shareway connection through the northern suburbs (Stage 1 Stanwell Pk to Coalcliff). This is supported by a budget allocation in the 2012/13 Capital budget of \$250K for "concept design of route" and \$750K in 2013/14 for the commencement of construction and on-going design.
7/06/2012	3	Footpath maintenance, LHD near Denmark Street Wombarra	NF2 request that the the footpath on LHD near Denmark Street, Wombarra needs maintenance and repairs. Can Council please rectify?	Infrastructure	A council officer will inspect this section of footpath on both sides of L.H.D. and decide if it will be included in the 2012/13 footpaths scheduled maintenance program.
7/06/2012	4	Maintenance of footpaths, Coledale	NF2 request that works supervisors ensure that grass and vegetation growing over footpaths is properly maintained to ensure that the surface of the footpath is not impacted upon. NF2 request that the vegetation is kept back to the extremities of the tar.	City Works	The matter will be looked into by Northern Depot.
7/06/2012	5	Dogs on Sharkey Beach, Coledale	An NF2 member stated that the Lord Mayor admitted that Council doesn't have the resources to enforce the Dogs on Beaches and Parks Policy. Further to this, NF2 request that the policy then be rescinded. If that is not feasible, can the dog off-leash area be moved to Heady's Beach with an additional fenced-off dog park on the adjacent grassed area?	Regulation Enforcement	No matter what form the policy takes, or which areas are designated as offleash areas, dogs in public places still require an enforcement component. Council manages enforcement with the current Animal Control Ranger resources it has available. This Policy is not due for review in October 2014. The proposed option to relocate the offleash area can be made when the policy goes on public exhibition during the review process.
7/06/2012	6	New Bubbler at Sharkey Beach	There is a new bubbler at Sharkey Beach. Can Council please advise how this came about?	Infrastructure	A customer request was received and the Service Manager (Property and Rec) was consulted who said a bubbler should go in as requested to go along with existing infrastructure within the park.
7/06/2012	7	Coledale Community Hall Sign	NF2 members report that it appears that the Community Hall sign is due to be moved. Can Council confirm how much this	Community Cultural Library Services	The new sign is going a few metres away from the existing arch sign, relocated for better visibility. We are phasing out the arch signs because they are rusting from the inside out. Some of the signs, such as this one,

near the ocean are destroyed by rust within 10 years. It is being replaced because the information was due for updating, the rusting of the sign and the rebranding of council facilities and buildings. The cost of the sign is about \$7000, and will be installed early July. This cost covers design, production, boilermakers, site investigation works and installation. While the cost of the signage may seem high the long life of these signs makes this initial investment worthwhile.
