

# DETERMINATION AND STATEMENT OF REASONS

## WOLLONGONG CITY COUNCIL – WOLLONGONG LOCAL PLANNING PANEL (WLPP)

Public meeting held at Wollongong City Council, Level 9 Function Room, 41 Burelli Street, Wollongong on 19 November 2020 opened at 5:00pm and closed at 6.24pm.

### MATTER DETERMINED

DA-2020/1033 - Lot 101 DP 737118, Lot 101 Lawrence Hargrave Drive (as described in detail in schedule 1).

### PUBLIC SUBMISSIONS

The Panel was addressed by one submitter.

The Panel heard from the applicant's representative.

### PANEL CONSIDERATION AND DECISION

The Panel considered the matters listed at item 7, and the material presented at the meeting and the matters observed at site inspections listed at item 8 in Schedule 1.

The Panel determined to refuse the development application as described in Schedule 1 pursuant to section 4.16 of the *Environmental Planning and Assessment Act 1979*.

### REASONS FOR THE DECISION

The reasons for the decision of the Panel were:

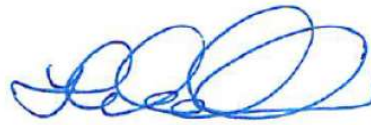
1. That the development application be refused for the following reasons:
  - (a) Compliance with the NSW Rural Fire Service advice would fundamentally change the proposed storage structure;
  - (b) Insufficient information has been provided by the applicant with respect to:
    - (i) Type of goods to be stored and whether it is considered an intensification of use.
    - (ii) Treatment and collection of roof water runoff.
    - (iii) Surface treatment and drainage details of the carpark.
  - (c) The applicant has not demonstrated that the current use is operating in accordance with the existing approval and conditions.
  - (d) There is insufficient information to understand the environmental impacts of the proposal.
2. The panel notes that Council's Regulation and Enforcement Team are investigating the alleged unlawful storage of buses on the property.

The decision was unanimous
