C CAG Report to NF4 - 3 May 2022

Supplied by CCAG Committee.

1. Rezoning of the Corrimal Coke Works site - the LEP Amendment for the Corrimal Coke Works Site was published on Friday 29 April 2022 by the Department of Planning and the site has now been rezoned. The post exhibition report to Council on the site-specific Development Control Plan (DCP) Chapter, and a report on the proposed Voluntary Planning Agreement (VPA) are being finalised.

This appears to confirm our fear that the community voice is not being heard in this process, as evidenced by:

- **Size** The DPE has approved the rezoning for 550 residences on the site. **Comment** the community has pointed out that 550 residences is significantly oversize for the surrounding transport infrastructure to handle. The developer has justified the size with a claim that many residents will travel by train, cycle and walk, hence not require a car. This is completely unrealistic given the very poor train service and generally inadequate public transport to access all parts of Wollongong, along with a car-based culture that continues to dominate the region.
- Traffic the Executive Director of Local and Regional Planning at DPE, Malcolm McDonald, said "The intersection of Memorial Drive and Railway Street would be upgraded to ease congestion and improve safety for motorists and pedestrians."
 Comment The community has repeatedly pointed out that the developer's traffic studies for the area are flawed and in Nov 2021 it was revealed that Transport for NSW eventually agreed that the impact of the proposed 550 dwellings will have a huge impact on surrounding streets, and that improvements to the intersection at Memorial Drive would not solve the traffic problems the development will create, but just move them to surrounding streets.
- Heritage Malcolm McDonald stated, "The site's character will be retained by preserving two iconic chimney stacks, coke ovens and the old powerhouse building."
 Comment This ignores the many requests of the community to include a broader definition of heritage to include not just industrial but also Aboriginal and ecological. The concerns of the Aboriginal community to protect their sites has been ignored, while the same applies to protection of the Endangered Ecological Community in the NW of the site and the creek line.
- **Open green space** Malcolm McDonald also stated that, "Half of the land is reserved for green space..." That is 9ha.

Comment - This is very misleading as it includes the 11m wide swathe of new inaccessible creek line, and the area to be protected for GHFF camp site.

Despite our voices being largely ignored to date, it is very important that the community remains involved and comments on the DAs when they go on public exhibition. According to Kate Strahorn (ICC) the first is likely around October this year.

- 2. State Heritage listing of the Coke Works site has not been finalised and remains a draft/proposed listing awaiting Ministerial approval and gazettal. The draft State Heritage Curtilage recommended by the NSW Heritage Council to the Minister for Heritage can vary to Council's LEP curtilage as they are separate listings and require different considerations under different Acts. The recommendation made to the Minister by the State Heritage Register Committee included a curtilage limited to the NE of the site, basically covering the current industrial footprint. It completely ignored any protection for the Aboriginal or ecological heritage of the site and provided the developer with an extraordinary degree of freedom to go ahead with large scale infrastructure demolition, vegetation destruction and creek relocation.
