Key points -

- A location is still to be determined for the replacement Park at Windang. WCC is working on “No Dig” sites. NF7 noted this has been ongoing for too long and nothing seems to be progressing
 - o **Action – Joanne Page to take community concerns into account**
- There will be an additional skate park at Port Kembla (in design for 2026/2027). Actual location to be determined. This is in addition to the Skate Space on Military Road.
- The SQUID is currently planned for construction winter 2025
- Gabions - construction 2025
- Warrawong CBD roads & traffic management will be adapted to suit the needs encompassing the Southern Suburbs Community Centre & Library, Warrawong Parklands & Warrawong Plaza Residential Development.
- Port Kembla Community Centre Upgrade. (This will also have toilets open to the public M-F)
The crossing in this location will also be upgraded from a safety perspective.

Other Points

- WCC is close to submitting a report on Windang Foreshore Options and will present these to the community shortly after.
- There are funding issues that NF7 has requested which include Wollomai Point Natural Area increased maintenance along with 25-27 Grandview Parade Natural Area maintenance need addressed. This is, along with Port Kembla Promenade Public Toilets to be kept open all year round
 - **Action – Peter Maywald to include in submission comments**
- Joanne Page mentioned that there is a new program in the Town Centre Blitz which will involve a crew go around assess the need for activities like gardening, painting, landscaping
 - **Action - Kaye Adams to investigate and forward any information available**
- Submission Close May 7, 2025
- Every submission is reviewed and assessed
- The Forum asked if it is worthwhile getting community input from the community. We have a list of projects that we would like to see addressed. Nathan McBriarty advised that work starts September/October and project requests can come to them directly or through the Councillors. Nathan advised he would forward information to allow us to assess criteria and provide them with the necessary details from a forum perspective. Joanne Page advised NF7 to work on 3-4 years out.

Merinda Wharf

- Kaye Adams reinforced that there is a lot of work going on in the background with various government agencies regarding Illegal Campers.
- At Merinda there is a division of land ownership where the area along the foreshore is owned by Crown Lands & the area closer to Northcliff Drive is owned by Wollongong City Council.
- The signs have been erected by WCC on their land and are waiting for signage from Crown Lands and are waiting for this until further steps can be taken.
- Discussions with WCC and Minister Scully have reiterated that this is a long process, and the Government parties cannot take any action until firstly the Crown Land signs are installed and then a consultation process takes place to assist any homeless campers
- Minister Scully has advised this Reserve is being regulated by WCC
- Other members of the forum advised of issues witnessing illegal campers washing dishes in the lake and urinating in the area.

- There is also unregistered vehicles located in the area
- Members of the forum also advised there are dogs of leash at the Wharf

Kully Bay Illegal Campers

- Minister Scully has advised the NSW Govt is working through Ownership & Legal Issues before they can proceed along a similar path to that at Merinda Wharf
