We're encouraging everyone to explore some of our lesser-known beaches and rock pools. There are so many options to choose from when it comes to going for a swim. In our city we've got 17 patrolled beaches, 9 unpatrolled rock pools, 6 patrolled freshwater pools and 3 patrolled saltwater pools. That's 35 different places to go for a swim!

For those travelling around the Wollongong CBD, don't forget to use the Free Gong Shuttle Bus. The Free Gong Shuttle Bus runs every 10–20 minutes and stops at the railway stations, the hospital, the centre of Wollongong and the beach. And remember, if you're driving on a particularly hot or busy day to keep an eye on Live Traffic for real-time updates.

Brush up on your knowledge before taking your dog to the beach. All dogs are not allowed on rock platforms or in rock pools at any time. This rule is in place to protect native species, plants and waterways.

Council's Compliance Officers will be working these holidays to remind people about their responsibilities as pet owners. Be warned that for those who do the wrong thing, fines can be as much as \$330.
