- c. Work has commenced on intersection of West Dapto Road, Stage 2 preliminary work has commenced. Also Corner work Shone Avenue & Wongawilli Rd is underway.
- d. Northcliffe Drive overpass planning well underway.
- e. West Dapto Road- Princes Highway- Reddalls Road in urgent need of attention. This has been noted in submission to Council Planning. This hill on Wylie Road is causing drainage issues as Storm Water flows cause problems on West Dapto Road.
- f. Freeway Access Report: Robert Cummins advised that report into freeway access will be ready in a few weeks.
- g. Darkes Road Closure 10 weeks seems excessive. NF8 will write to planning re more consideration of need to limit disruption to local traffic.
- h. Bus Stop Shelter WCC aiming to move Bus Stop to outside Aldi and seek to install bus shelter.
- i. Tallawarra B Power Station- 24.6. 24- commenced commercial operations. Minimising impacts on aviation by installation of plume dispersion equipment.
