I notice we have a separate customer request from NF8 for other updates so have provided a response to these below also.

# Dapto Bus Stop

I have been informed that the bus seat relocation under the awning at ALDI should have been actioned last week.

The delay was due to sign ordering (delays in receiving updated signs).

I'll try find some time to drive past this week however if you notice the signs and bus seat are still not correctly installed, let me know and I will chase this up.

# Mt Brown parking signage

Council is awaiting feedback from TfNSW regarding the matter.

I have contacted TfNSW again today requesting a response as soon as possible.

I do note (anecdotally from driving through here) that less vehicles appear to be parking on the street. Has NF8 seen this behaviour change also?

## Speed limits after fatal crash on West Dapto Road

Transport for NSW (TfNSW) has responsibility for reviewing and setting speed limits in NSW. All requests for an assessment or a review of a speed limit can be submitted through the following link: Speed limits - have your say | Transport for NSW.

Council has requested TfNSW review the speed zone between Sheaffes Road to the existing 50km/h zone near Shone Avenue as part of the West Dapto Road Upgrade project. The speed zone change will be installed (if supported) during construction of this upgrade.

There are currently no short-term plans for West Dapto Road to be upgraded north of Sheaffes Road meaning any speed zone reduction would need to be requested to TfNSW directly and be based on current road conditions.

Regarding the fatal crash, Council is awaiting the formal Crash Report from Police and TFNSW. Once Council receives this report, our Transport Team will investigate potential safety improvement opportunities as part of our fatal crash investigation process.

## From Paul Tracey, Manager Open Space + Environmental Services

Thanks for the enquiry from NF8 via Cr Campbell.

Our team have inspected the trees along station street.

The species – Native Brush Box are really resilient to this type of pruning, and whilst I agree they don't look great, they still provide a shade benefit along the footpath for pedestrians.

We expect they will survive, and as such removal and replacement is not something we would allocate resources to at this time.

Unfortunately Endeavour Energy continue to prune trees like this across the Wollongong LGA, and we are unable to stop it as they use powers delegated under the electricity supply act.

The challenge with replacing trees at this site is we could only plant a species with a maximum height that does not grow within 4 meters of the high voltage lines (top 3 lines in the image) otherwise the pruning will continue.
