The term of this Program will end with the Council elections in September, however, the Committee will go before the new Council requesting a new term so the LIEMC will continue on as is.

8 RECONCILIATION ACTION PLAN (RAP) FOR CHILDREN'S SERVICES

Develop a RAP for Pre-schools, Day Cares etc.

Hold a 2 day Reconciliation Symposium to help/support each Centre to develop a RAP.

Encourage regular contact with Elders and Aboriginal people. Make them feel comfortable to "hang out" at their Centre and to develop an ongoing relationship with the children at the Centre.



RAP can help develop reconciliation with the children from an early age and this will flow through to their families.

Ensure the RAP is reported to the Board Members of the Centres each month so plans and ideas are looked at and ticked off as achieved.

Mentor and Guidance from the Aboriginal Reference Group in this area is greatly appreciated.
