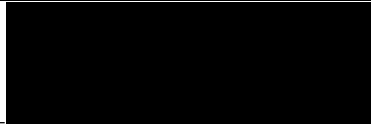

SECTION A – REAL PROPERTY

SECTION B – SOURCES OF INCOME
