This item is presented by Martine Fraser, Environment Strategy Officer at Wollongong City Council. Wollongong City Council and Shellharbour City Council have been monitoring water quality and estuary health in Lake Illawarra since October 2013. This activity was included as action WQ7 in the Lake Illawarra Coastal Management Program “Implement water quality monitoring programs for estuary health, recreational use and physico-chemical and bacteriological indicators in the Lake and its catchment.” This is a presentation on the report for the monitoring period from May 2021 to April 2022, focussing on those measurements that are especially important for assessing the lake condition for its ecosystem health and recreational use.
