

#### **PROPOSED PARKING CHANGES – BONG BONG ROAD, DAPTO**

Following a Council review of the Loading Zone usage at Bong Bong Road in late 2022 and requests relating to the existing Taxi Zone creating congestion concerns, Council are proposing changes to parking restrictions in the area. These proposed changes are summarised below and illustrated on the following page.

#### Loading Zone Changes

The proposed Loading zone will be lengthened (from 10m to 18m) but operation restricted between 5am-10am Monday to Saturday. Therefore, loading and unloading of goods are proposed to only take place between these new hours. This is based on feedback from businesses in the area which revealed the zone is largely underutilised. The zone will become a Taxi Zone outside of loading zone operation times.

#### **Taxi Zone Changes**

Approximately 18m of the existing Taxi Zone on the northern side of Bong Bong Road will be relocated to the southern side and combined with the new 18m long Loading Zone. Taxis are not permitted to park for extended periods of time during Loading Zone times however they are able to pick-up and drop-off passengers in accordance with NSW Road Rule 179.

The proposed changes are largely to increase the storage capacity of vehicles waiting at the Princes Highway/Bong Bong Road Traffic Signals. It is expected the increase in storage length will decrease congestion concerns raised.

#### **Timed On-street Parking Changes**

# The removal of approximately 6m of on-street timed parking will be required (equivalent of one-car parking space) to accommodate the proposed changes.

Council is seeking feedback from representatives of Neighbourhood Forum 8 (NF8) as part of its consultation process prior to submitting to the Wollongong Traffic Committee for review/approval. - We are a group of local children from Wongawilli.
- We love living in our area, which is continually growing with young and older families alike.
- Many families have connections to family from this area prior to urban development and have a great love and respect of the area.
- We have a great park but it's limited to younger children. The older kids require more sporting amenities which are not available in the Wongawilli precinct.
- We have two areas of open field play: one is Bankbook Park, provided by the developer and the other is the land beside the Wongawilli Hall, (which is to be upgraded to a Community Centre).
   Both areas are now swales for water retention.
- An ideal solution would be for council to provide a basketball half court in one of these locations to provide a suitable sporting outlet for local children. This should be included in next 12 month budget.
- We are currently looking at the cost of this and will forward this information to council once received
- We are prepared to assist council by seeking some sponsorship for this facility
- Included in the plan should be some seating for parents / career to supervise children.
- We currently have to travel some distance to find a suitable sporting ground location, along busy streets. The current bike path, while great, does not connect at the intersection of Wongawilli Rd, West Dapto Rd & Shone Ave.
- The basketball court will provide local children with the ability to improve not only their basketball game playing games of basketball, the court can be a platform for other workouts. From cone drills and sprints, yoga or soccer / hockey practice, individuals and families will always have a reliable, consistent surface to lead a healthy lifestyle.
- Community engagement would be lifted with Easter hunts and Christmas parties held near/on the court.
- A petition is currently being circulated amongst the local children for them to show their support. Email addresses will be approved by their parents.
- Once the local community engagement is complete we wish as a group of children to present this proposal at a Council meeting.

The Neighbourhood Forum 8, representing the Dapto community, strongly supports the West Dapto Master Plan and the requisite infrastructure needed to be successful. A key component being the requirement for 5 new primary and 2 high schools in the region.

As you would be aware, West Dapto is one of the fastest growth corridors in the state of NSW, notwithstanding this, no land has been allocated, no funding secured and there appears to be void with respect to any timely planning.
