Cr Aitken

• Korrungulla – Investigations by the EPA are ongoing and council will advise action has been taken.

Cr Figliomeni

- WCC ran an outdoor dining trial which proved quite successful. Council is now reviewing its policy to and aiming to expand throughout the LGA.
- Cat Containment Review Refer 6.1.

 Cr Figliomeni explained that whilst valuations have increased dramatically in certain areas of the LGA, Council does not receive any benefit from the revaluation and all the benefit flows through to the NSW Govt. The revaluation has a cost to Council in that Council rates can only be increased by the Independent Pricing and Regulatory Tribunal approved rate and that the land revaluation requires Council to reallocate the rates but limited to the Ipart cap

6. Business Arising from Previous Meetings

6.1 Responsible Cat Ownership

- Cr Figliomeni advised that that the Council briefing considered the issues from a complaint's perspective rather than for protection of wildlife and four options were put forward in the briefing Cr Figliomeni has also spoken to the RSPCA who are pushing to change legislation regarding cat containment. NF7 is looking at this issue from a wildlife perspective.
 - Action Continue to monitor and leave on agenda for further mention.

6.2 Northcliffe Drive Traffic Survey

- Peter Maywald advised that he received clarification of the Traffic Survey figures but noted that the truck movement needed to be clarified.
 - Action Peter Maywald to follow up.

6.3 King Street/Berkeley Boat Harbour Free Camping & Windang Illegal Camping

- **Council Land** There is a van camping on Council Land at Windang also at Heritage Park Windang. There is an issue with enforcement of "No Camping" as Council Rangers are not readily available at night when the overnight camping is illegal.
 - Action Councillors to review to find a solution
- State Govt Land -Of particular concern is King St -there only appears to be 2 rubbish bins on the site, no water and no dump site for the RVs & motorhomes attracted to the site. The Forum acknowledges that there needs to be a middle ground to cater for the homeless members of the community. With the current lack of facilities, the Forum is concerned about the effect that waste disposal may have on the lake.
 - Action –Now that we are out of "Caretaker Mode" Peter Maywald & Kaye Adams to send a letter to Paul Scully MP asking for assistance in this area and noting the sensitivity of the homeless community
 - Action Forum to also consider contacting EPA to test the water

8.1 Council Natural Reserve –25-27 Grand View Parade Lake Heights

• Additional Local Residents have again raised the issue of the unkept reserve. The reserve is overgrown, and is used as a rubbish dump. The residents also question the effectiveness of the storm water drain with all the weeds growing in the drain. As it is classified as Natural Reserve, when trees and branches are removed they are left for the little creatures, which in theory is fine, however with all

the Wandering Jew the residents also question if this is the correct course of action. Photos were tabled and supplied to Cr Aitken (See Attached Photos)
