It has been an important feature of NF4 that we have enjoyed the direct involvement of Cr R Martin and Cr C Walters from Ward 1, in the meetings to provide factual guidance and perspective into the working of Council and it is also pleasing to note that Council's Engagement Team do genuinely appreciate the opportunity to gather information from residents through meetings such as NF4.
