ANNUAL INTERNAL AUDIT AND RISK MANAGEMENT ATTESTATION STATEMENT FOR 2024-2025

On 1 July 2024, provisions within the *Local Government (General) Regulation 2021* came into force to require all councils to have a risk management framework and an internal audit function and to prescribe membership requirements for audit risk and improvement committees.

Councils have been required to comply with these requirements for the year beginning 1 July 2024 and, starting with the 2024–2025 reporting period, must attest to their compliance in their annual reports.

Council endorse the Internal Audit and Risk Management Attestation Statement to be signed by the General Manager.
