The Forum continued to talk about the foreshore and it was noted that there was no representation from State Government and the Head of the Lake Illawarra CMP Implementation Group

There is still a replacement playground required. It is understood that the playground under construction in Wattle Street Windang was already approved prior to the dismantlement of the foreshore playground. The replacement location is being challenged by potential erosion and aboriginal burial grounds.

## • Responsible Cat Ownership – Alison Byrnes MP

Correspondence reply was received and was more directed to the matter of Feral Cats. While NF7 has always believed this to be an issue, the matter of concern the was not addressed by Alison Byrnes MP was Responsible Cat Ownership and the effect of domestic cats on our wildlife.

Cr Martin has supplied a list to the State Govt requesting No Camping Signs. Also, it is a major concern as to hygienic practices with the sensitivity of the lake

Here is some info we received after asking questions about the timing of the device at PK. Forwarded for your information. Dear Lord Mayor and Ward 3 Councillors

Thank you for your email of 9 January 2024 requesting an update regarding the timeframe for installation of the drainage device at Port Kembla. For your reference this was recorded under Councillor Request CR0244610.

We are working towards installing a purpose-built Stormwater Quality Improvement Device at Port Kembla to capture gross pollutants, including rubbish that would otherwise end up in the ocean.

We are modelling the effectiveness of the device and live testing in a laboratory the performance and the materials, to ensure they are built to last.

Our vision for the device remains largely consistent with the concept design that was presented previously at a community drop-in session.

Some of the valuable community feedback we incorporated into the design includes:

- Ensuring the device can capture small litter like cigarette butts and syringes.
- · Minimal changes to the visual amenity of the area.
- Construction planned in winter to minimise disturbance.
- Causing minimal changes to car parking for the proposed location.
- Building a device that captures pollutants from the entire Goat's Creek catchment, up to certain flood levels.
- Ensuring the device can survive high flows during large events as well as have minimal stormwater impacts.

This project has proved to be more complex than first anticipated. We soon recognised that devices currently available were unsuitable for this site, considering the feedback received from the community.

It is taking considerably more time and resources to design, test and optimise a brand-new, custom-built device. However, what we learn from this project can be used across similar locations across our waterways and ocean.

Additional time was also required to find a suitable contractor for construction who would be able to construct during the foreshore off-season. As such, the construction stage is now planned for over the winter months of 2025.
