6 Responses 6.1 Parking for Carers & Service People:

It was agreed to:

- 1 re-iterate to Council that what is needed is the strategic placement of some time-limited parking spaces to enable access for increasing needs for in-home care and maintenance services
- 2 request the General Manager to provide a report on this issue in Council's agenda for consideration and review.

It was agreed that Council be requested to increase substantially safety signage on shared paths particularly in relation to speed limits.

7 Reports 7.1 Closed Council Meetings

It was agreed:

the Office of Local Government be congratulated for an excellent discussion paper which, amongst other things, aims to provide greater transparency to the conduct of NSW Councils;

- a submission be made to the Office of Local Government supporting the abolition of closed briefings, to increase council's transparency and increase the community's trust in Council;
- 3 support is sought from Council and Ward Councillors to stop having closed briefings, or at the very least allow a trial period for public access to these meetings.

7.2 Neighbourhood Forum 5 meeting arrangements

It was agreed that Council, and the incoming Lord Mayor and Ward Councillors be implored to resolve the NF 5 meeting room situation by providing a Council facility and cover any public liability risk either by adjusting the terms of meeting room occupation or taking out separate insurance cover, as occurs with other Councils.

7.3 Corrimal Street Footpath:

It was agreed that Council be requested to review the safety of the Corrimal Street western footpath between Gipps and Kembla Streets.

It was agreed that Council be requested to advise progress with this Plan.

9.1 Incoming Ward Councillors

9.2 Mount Ousley Interchange

It was noted that a report was tabled which included background information and 9 safety issues which need to be addressed. It was agreed that the executive make appropriate submissions based on these points.

9.3 DA-2024/701. Dual occ 13 Shoobert Crescent Keiraville

This is a proposal for a dual occupancy on a relatively remote site. It does not conform to setbacks, has virtually the entire frontage taken up with garages and does not conform to our locality plan for Keiraville



It was agreed that a submission of objection be lodged.

9.4 DA-2024/722. Dual occ 49 Mangerton Rd Wollongong

This is a proposal for a dual occupancy on a steep, awkwardly shaped, site with access from Norman Street to preserve the trees along Mangerton Road. There are some minor set back infringements due to the shape of the site, and it does not quite comply with our locality plan for Mangerton



It was agreed that a submission of no objection be lodged.

9.5 Council Web site notifications

It was agreed to enquire of Council why the wrong date for the NF 5 meeting is still shown and why only the first page of the agenda was included on the site and not the whole document.

9.6 Improved safety on M1 at West Wollongong

It was agreed to request TfNSW to improve signage on the M1 to notify the need for motorists to have to merge out of the left hand lane to the through lanes to travel past the Figtree exit when travelling south.
