C. Correspondence received from Romeo Cecchele (7.11.2022)

Here are some very important items that we are still waiting for a coherent response from our Councillors and senior management of Wollongong City Council being:

1. West Cleveland Road-Major Subdivision entry point for Stocklands Brooks Reach (Forest Ridge) new subdivision estate which is destroying Cleveland Road between Fowlers and the entry point of the new subdivision. Why is this being allowed by WCC?? No reply from previous two months!!
2. Darkes Road before the intersection of West Dapto Road is being destroyed by very large trucks and earth movers that are using an entry point to the new earthworks in this adjacent corner which is resulting in this part of Darkes Road collapsing and subsiding on the edge of the west bound lane! Why is this being allowed to happen by WCC?? This has been raised before and developer is doing it again!!
3. Bong Bong Road/Burringbar/Hamilton Streets are the first point of serious major flooding in Dapto since its beginning and with lives being almost lost there at nearly every flood event why has WCC not done a major upgrade here in the last 43 years?? When will it be done??
4. Lucas Drive multiple potholes between Bovard and Fairwater Drive-already the large number of potholes that were EVENTUALLY filled in by the slap fill method by WCC two weeks ago are coming apart in multiple places on a major link road!! When is this road going to receive a major upgrade of high density bitumen??
