PROPOSAL

Local Government NSW Annual Conference

The LGNSW Conference presents a valuable opportunity for Councillors to engage with peers from across the state, exchange ideas, and debate key issues shaping and informing the development of future NSW Local Government policies. Participation in this event supports informed decision-making, strengthens advocacy efforts, and fosters collaboration across councils.

Voting entitlements

Wollongong City Council (Council) is entitled to nominate up to seven voting delegates, all Councillors are entitled to attend and benefit from the networking, learning, and strategic discussions the conference offers. Council's representation at this event will ensure our community's voice is heard and our interests are well represented.



Normal Council practice is to nominate the Lord Mayor, Deputy Lord Mayor and five other Councillors as voting delegates.

Program

The 2025 conference will be held between 23 and 25 November 2025 at the Panthers Penrith and Western Sydney Conference Centre.

2025 Australian Mayors Summit Against Antisemitism

Cr Ryan Morris has requested to attend the 2025 Australian Mayors Summit Against Antisemitism. The Summit will showcase the role of local government in confronting antisemitism, fostering social cohesion, and strengthening inclusive, resilient communities.

Program

The 2025 Summit will be held between 3 and 5 September 2025 on the Gold Coast, Queensland.

SUSTAINABILITY IMPLICATIONS

Council encourages Councillors to utilise digital copies of business papers for conferences rather than printed copies, and to travel by the most economical means.

FINANCIAL IMPLICATIONS

Council has a budget to enable Councillors to attend conferences and meet associated costs and sufficient funds are available for the costs outlined in this report.

Local Government NSW Annual Conference

Registration: Early-bird registration for the conference is approximately \$1,385 (incl. GST) per Councillor. The fees include online business papers, the President's Welcome Reception, Conference dinner, two-day business sessions including morning and afternoon tea, lunch, and name badge.

Accommodation: will cost approximately \$260 per Councillor, per night as required. Councillors may stay up to three nights depending on their individual circumstances and attendance at various sessions and associated conference events.

Other expenses: Councillors may claim for reimbursement of incidental expenses, supported by itemised tax invoices or receipts in accordance with the Councillor Expenses, Support and Facilities policy.

2025 Australian Mayors Summit Against Antisemitism

Registration, accommodation and air travel are coordinated and funded by the Combat Antisemitism Movement who are the organisers of the Summit.

Reimbursement of other costs, including travel/transfers and meals not included in registration would be provided for under the Councillor Expenses, Support and Facilities Policy.
